

BOARD OF DIRECTOR APPLICATION INSTRUCTIONS

For persons wanting to serve as a PWSC Director

- To be listed on the ballot as a candidate for a director's position, a person must file an application with the Corporation that includes:
 - The person's written consent to serve, if elected;
 - o Biographical information about the person; and
 - A statement of the person's qualifications, including a statement that the person has the qualifications prescribed below.
- To be qualified for election or appointment as a director, a person must be:
 - Eighteen (18) years of age or older on the first day of the term to be filled at the election or on the date of appointment
 - o A member of the Corporation.
- In addition to the qualifications prescribed above a person <u>is not qualified</u> to serve as a director if the person:
 - has been determined by a final judgment of a court exercising probate jurisdiction to be:
 - totally mentally incapacitated; or
 - partially mentally incapacitated without the right to vote; or
 - has been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities.
