Re: CY2024 Water Rate Increase Letter

Your elected Board of Directors of Picosa Water Supply Corporation (PWSC) approved the Calendar Year 2024 Budget and Water Rates. This letter is to communicate to you, our members, that management has determined the need to increase water rates by a minimal 2% this year. This decision was made after a detailed study of both revenue and expense budgets and considering the ever-increasing material costs, labor costs, and growth of our water system.

Our Mission at Picosa Water Supply Corporation is to continue to provide safe, high-quality water and services at an equitable rate for all our customers. To sustain current budget requirements for operational and reserve costs, we must adjust our water rates to produce the necessary revenue needed to cover all system costs. We also need to be prepared to provide water services to future landowners and developers. That will mean major infrastructure improvements to ensure we can provide water to all those who need it. Our customer base has grown significantly in the last 5 years, and we estimate it will continue to grow much more in future.

In April 2020, the Board implemented a ten (10) year Growth Preparation Plan to place monies aside for future Capital Improvements. Also, in May 2021 the "Impact Fee" (formerly Buy-In Fee) was increased specifically for new customers, to support the future growth of our system. That growth has already begun. Our customer base has increased by 25% in the last 5 years.
